Item #1: The CDBG Year 38 applications are due on March 22, 2016. The office has prepared the application package and delivered the documents to the Program Director.

Item #4: The Railroad Quiet Zone along Horton and Town Center is still being researched. It appears that the process will be more difficult than initially thought, as the River Road Grade Crossing in Westville will have to be improved and included in the quiet zone. The traffic study in Westville will commence in the month of May.

Item #8: On March 15, 2016 our office hand delivered the required copies and digital cd version of the RFP for the next round of HOME funds.

Item #9: An application for Camden County Open Space Recreation Facility Enhancement will be completed for the March 31st deadline. We will use the funding the walking path along the waterfront.
