# **Open to the Public:**

Jim Everett, 111 Browning Road, asked about the reassessment of the town and its effect on the taxpayers. Administrator, Ryan Giles, explained that the county has the borough assessed approximately 21% higher than they have the borough assessed. The reassessment will bring us even with the county. This will lower individual assessment and increase our tax rate. The whole process will keep our total tax base neutral. For example, if we have a 5,000,000 dollar base. We will do our reassessment and after all the adjustments to the assessed values, we still will only be collecting 5,000,000 dollars. Mr. Everett asked about a water allocation agreement in Westville. Mr. Giles said that there is an agreement to send a specific amount of excess allocation we are allowed for water to Westville. This is not actual water, this is a paper transfer of the amounts towns are allowed to pump in a given year. The total amount agreed is 75,000 dollars spread across 5 years. Mr. Everett pleaded with council to get together with the school to help fix all the issues they are facing. Mayor Branella thanked him for his questions and input.

Elena Young, 214 Browning Road, explained that the apartment complex is over run by animals and the property is a disgrace. Police Chief Ellis said that he is well aware of the issues and this is the hottest topic in town right now and we are addressing issues as they come in. He encouraged that people need to call about everything going on with the location so we can correct the problems.

### **Engineers Report from Greg Fusco, Kei Engineering:**

Mr. Fusco said there is very little update this month and went over a couple items.

Item #1: CDBG Year 38 funding and application should be out within the next few months. When it's available, the county will send the application to the borough.

Item #7: NJDOT Municipal Aid for Sixth Street reconstruction has been suspended by the state. The field survey and preliminary engineering has been completed and will be ready to bid once the state lifts the freeze on the funding.

Item #13: We are waiting on the DEP for our application for the pump station on Creek Road under the USDA. When we receive approval, we will commence with the bidding process.
