Public Meeting May 19th, 2014

Open to Public:

Jim Blymer, 20 Second Street, spoke of his concern of the new Broadway bridge project not fixing the flooding issue. It was originally supposed to raise the road up to the railroad tracks in Gloucester. He said he spoke to some of the contractors and they said that part of the project is not going to happen. He feels that this bridge project will not fix the flooding issue that hinders our resident's ability to leave the west side of town. Mayor Branella said she would reach out to our county representative and express our concern. Mr. Blymer also expressed his concerns over the Old Salem and Creek Road Project that will place a traffic light on Route 130 and block drivers making a left onto Creek Road from the Brooklawn Circle. He feels this is going to create more of a problem on the Circle. Mayor Branella said that his concerns are noted and will be brought up to the DOT representatives at a meeting next week.

Pat Newcome, 117 Pennsylvania Road, said she is getting tired of these cats roaming onto her property. She said they are unregistered and thinks the neighbor is caring for them. Mayor Branella explained that there is a new ordinance for animals. She asked Mrs. Newcome to see her after the meeting to discuss in more detail.

Dan Friel, 203 Pennsylvania Road, asked if anything is getting done about the lines being flushed for routine maintenance of water and sewer lines. He also asked about a no wake zone sign being placed at the waterfront. D. Domico, DPW Superintendent, said she knows the lines are still on the semiannual maintenance schedule. She said she is still in the process of getting a new wake zone sign put in along the water. Mr. Friel asked if anything at C & L Machines is getting done for a new building. He feels it looks terrible with all the equipment everywhere. Mayor Branella said they are still moving forward with a new building. She said she will reach out to them and see where they are with the project.
