Item #8 – The fire house and water plant roof replacement project is still in the spec building phase. We are going to have two alternates for bidding. Hope to advertise by end of October.

Discussion/Committee Updates

Ryan Giles, Borough Clerk:

He informed council about the new textile recycling program that will begin in a few weeks. Every household will have unique bags to place all the clothes, belts, blankets, cloths, and shoes they no longer need. Anyone who places a bag out front of their house will receive a new bag to replace the one taken. The pick-up will be once a month. He explained that the borough will receive .10 per pound / \$200 per ton. With the cost of \$65 dollars per ton to dump our trash, we will save approximately 3 tons of trash tipping fees for every ton of textiles recycled. We are also the second town in the state to start this program.

He explained that the Best Practices worksheet was completed. We scored 39 points out of 50. This will penalize the borough 20 percent of the last state aid payment or 1 percent of the total aid for Brooklawn. Everyone wants to make sure we fix the points we did not receive for next year.

The school referendum is scheduled for December 10th, 2013. The school board has asked us to put together a few quotes for the referendum. If you have anything to say, please forward to the clerk.

Our code enforcer came across a new type on abandon property ordinance. This ordinance requires foreclosed homes to register their property with the borough for a fee. This ordinance fee only occurs if the bank is not actively seeking new owners for the property. Bellmawr just passed this type of ordinance in early June. The council asked the solicitor to have the new ordinance for the next meeting.

M. Mevoli:

Let everyone know that Halloween is from 3pm til 7pm. He asked everyone to enjoy all the trick or treat kids. He also mentioned that we have the hay wagon again for the hay ride.

G. Gilbert:

He told everyone that they have blueprints ready for the house on 304 New Broadway. They will be going out for proposal within the next month.

J. McCleary:

She invited everyone for the Arbor Day celebration on October 19th at Noreg Circle. They are planting a tree in honor of Tom MacAdams. The event is at 11am.
