PROCLAMATION FOR TAYLOR MOORE – Mayor Branella welcomed Taylor and her Mom Jenn to the Council meeting and talked about how Taylor was a great example of Brooklawn strong and had Taylor explain her goal of collecting canned goods for those in need during these difficult times. Taylor collected 882 food items. Mayor read the proclamation and congratulated Taylor on a job well done. Council members thanked Taylor for a wonderful accomplishment.

ENGINEER'S REPORT: Greg Fusco discussed the NJDOT 2021 municipal aid application which is due July 1. Greg stated the application will ask for funding for phase 2 which will include 1st and 2nd streets and Lake Drive. He stated additional funds would be requested to address the drainage issue next to the Community Center. The application will be submitted after the resolution is adopted by Mayor and Council. Greg discussed the final voucher and final change order for the slip lining work regarding the sewer project. He stated the project is completed on the sewer side and when the final cancelled checks are submitted the final outlay can be submitted for a July loan closing. Greg stated more work was done then was in the original scope. He also stated he is waiting for authorization from the USDA for the water plant improvements and then will be able to move forward with advertising for the project. Greg also stated the Camden County Open Space Application was submitted on time.

OPEN TO COUNCIL: P. McConnell stated that the 4th of July Celebration this year is cancelled and also gave an update on the dog park. P. Moses gave a Shade Tree update including a virtual tree planting for the school. Patrick also gave a Sustainable NJ update. M. Mevoli discussed the cameras throughout the Borough and discussed social distancing concerns especially with Memorial Day. The police committee met regarding the contract for Chief Ellis. J. Clothworthy gave an update on the Census. John asked what the plan was for some of our public areas. Mayor Branella stated we will be following the state's lead on the situation. Mayor stated we will be receiving signs to put out as a reminder the importance of completing the census. J. McCleary discussed the Borough homes and the progress of finishing the current projects. Julie also talked about the street renaming and the possibility of brining on the families to the next Council meeting to recognize the recipients. Julie also mentioned the website is coming along. Skip proposed the speed bumps be moved on either side of the stop signs and also run them from curb to curb so there is no gap. Mayor suggested that M. Mevoli, J. Granstrom and Chief Ellis get together to discuss a plan to resolve the issue and to include Greg Fusco. R. Giles stated a modified schedule is still in place in the office and that we will still remain closed to the public until further notice. Public works between both towns are still separated. Ryan asked everyone to make sure they have completed

their financial disclosures. Mayor closed the meeting by thanking everyone for all their efforts during these challenging times.
