- We received \$250,000 for reconstruction of Railroad and Old Broadway. We will begin engineering and go out to bid in early fall.

- We are continuing our USDA project. The sewer sliplining will begin within the next month. The water plant plans for an aerator is at the USDA for approval. Once we get the plans approved, we will bid the project.
