Engineers Report from Greg Fusco, Kei Engineering:

Item #1: The NJDOT approved \$125,000 for Phase #2 of the Reconstruction of Sixth Street. Administrator Giles said that there is money in Capital for all the engineering and will just need to do a fully funded bond ordinance when ready to move forward. Item#3: The Year 40 CDBG funding will be based on RFP. In the past we would receive approximately \$20,000 to do small projects for parks and recreational areas. This year they are going to award 5 or 6 projects worth \$100,000 to \$250,500. Administrator Giles said the deadline is April 13th and will do the RFP. The project will be to create ADA compliance on the site formerly known as Saint Maurice Church.

Item #11: The USDA water project is finishing up the current phase. We are gathering plans to modify the water plant in the next phase. We also sent plans for the Creek Road pump station to the USDA to get approved before sending them out for bidding.

Mr. Fusco asked council to approve resolution to allow his firm to submit application to County Open Space to build a possible Dog Park at the end of Paris Avenue. Everyone thanked him for his time.
