ORDINANCE OF THE BOROUGH OF BROOKLAWN, COUNTY OF CAMDEN, STATE OF NEW JERSEY AMENDING CHAPTER 145, WATER, OF THE CODE OF THE BOROUGH OF BROOKLAWN

BE IT ORDAINED by the Mayor and Borough Council of the Borough of Brooklawn, County of Camden, and State of New Jersey that Chapter 145, Water, in the Code of the Borough of Brooklawn, is hereby amended as follows:

ARTICLE I. SECTION 145-7 Schedule of rates.

A. Meter charge.

1. The quarterly meter charge to be imposed on all service connections within and without the Borough of Brooklawn for meter sizes less than 1 inch shall be:

a. Effective July 1, 2021: \$101.00.

2. The quarterly meter charge to be imposed on all service connections within and without the Borough of Brooklawn for meter size of 1 inch shall be:

a. Effective July 1, 2021: \$150.00.

3. The quarterly meter charge to be imposed on all service connections within and without the Borough of Brooklawn for meter sizes of $1\frac{1}{2}$ inch or greater shall be:

a. Effective July 1, 2021: \$220.00

B. Service charge.

1. Effective July 1, 2021, all residential, commercial and industrial customers within and without the Borough of Brooklawn shall be charged a minimum quarterly rate of \$101.00 per separate apartment, dwelling or commercial unit or user served by said water service connection after the first unit.

C. Retained in its entirety.

D. Retained in its entirety.

E. Multiunit apartment dwellings, commercial customers and shopping centers.

1. Effective July 1, 2021, in the case of multiunit apartment dwellings, commercial customers and shopping centers, where units are not individually metered, the total number of units serviced per water service connection after the first unit shall be multiplied by \$90.00 to determine the minimum quarterly charge.

J. Notwithstanding any Section or Chapter of this Code to the contrary, the quarterly meter charge to be imposed on all service connections for properties subject to a \$250.00 reduction in property taxes pursuant to N.J.S.A. 54:4-8.40, shall be \$53.00.

K. Final water reading request will incur a fee of \$25.00

ARTICLE II. SECTION 145-8 Violations and penalties.

This Ordinance shall take effect upon passage and publication according to law.
