COMMENTS FROM MAYOR/COUNCIL/DEPARTMENT HEADS:

Council President J. McCleary discussed Borough Homes and gave an update on the progress of renovations to date. Julie also gave an update on the Brooklawn newsletter and stated she would like a meeting with Sandi Kelly in September regarding future time lines and completion of the newsletter. Council member McCleary stated the street naming that has been delayed due to the pandemic will take place during the Fall Festival. Council member M. Mevoli stated there was a recent incident at the Empire Diner where a customer was choking while eating and was assisted by owner Dervis Akturk who sprang into action to help by performing the Heimlich maneuver. Mayor Branella suggested posting the news story on Facebook. Chief Shamus Ellis discussed the Body Worn Cameras. Council member J. Granstrom stated on a recent walk that there were a few people cleaning along the boat ramp. Council member Granstrom stated they were not Brooklawn residents, but that they visit Brooklawn often and enjoy the waterfront and took it upon themselves to clean up. Council member J. Clotworthy stated if anyone needs help with any projects that he is there to help. Council member P. Moses gave an update on both the Shade Tree Commission and Sustainable New Jersey. M. Ostrom reported all is good with Public Works, keeping up with regular summer maintenance Mike stated an upgrade was done to the garden at water works, freshening up the mulch and rock garden. Mayor Branella stated some ongoing projects including do not knock need to be revisited. Mayor Branella requested Council Members to think about other projects that were discussed in the past. Police Chief Ellis stated about 40 residents have requested stickers "Do Not Knock" stickers. Mayor Branella requested the information be shared on Facebook. Mayor also inquired about the welcome packet and getting them out to new residents and to inquire with Maria Branson to provide addresses. Mayor Branella stated Tim Higgins will be drafting a letter in support of the new cannabis business coming to Brooklawn. Administrator Giles read a letter of support from a resident thanking Public Works for their hard work and efforts. The auction for 217 MacAdams Way was held and one bid of \$45,000 was submitted. Administrator Giles shared with Council the information regarding the plants for the Pershing Road bulkhead and also shared images showing what plants that will be used for the project.
