COMMENTS FROM MAYOR/COUNCIL/DEPARTMENT HEADS:

Mayor Branella thanked those that participated in the bag for hunger at Brown's Shoprite. Mayor also discussed the upcoming retirement party for Jim and Karen DiAmore at the American Legion on October 9th. Mayor Branella talked about the Patriot Day Services on September 11th at Memorial Park. Council President J. McCleary stated the Patriot Day services were televised on one of the local news channels. Julie discussed the Borough Homes and gave updates on renovations that are both completed and ongoing. Julie stated the newsletter will be going out this week and the winter edition is already being prepared. Council President McCleary also stated the street naming dedications that have been delayed due to Covid will finally take place during the upcoming Fall Festival. Council member Granstrom stated the Patriots Day service was very nice and he also stated he enjoyed participating in the bag for hunger at Shoprite. Council member P. McConnell discussed the schedule for the street sweeper and requested that the schedule be adhered due to residents moving their vehicles and expecting the street sweeper on the day it is advertised. Council member McConnell also stated there will be both hand washing stations and hand sanitizing stations at the upcoming Fall Festival. Council member M. Mevoli discussed the Patriots Day services held recently and thanked Mayor Branella for a wonderful speech. Council member Mevoli discussed the progress on the

waterfront development as well as the park benches, and stated it will take time and need to secure grants for projects.
