

October 2021 Press Releases:

10/1/21 Officers responded to the Wawa for a shoplifting. An unknown male placed 5 Red Bulls into his satchel and fled the store in a white Infiniti. The vehicle was last seen traveling north on Rt. 130.

10/1/21 During the course of an investigation of a motor vehicle crash at Rt. 130 and Browning Ln, an officer observed a gun in one of the driver's coat. A struggle ensued and the male broke free from the officer. The suspect then pointed the gun at the officer but then threw the weapon onto the roof of the Wawa and ran on foot into the wooded area. A perimeter was set up and the male was taken into custody shortly after. Jessie Davis, 21, of Philadelphia was placed under arrest and charged with possession of a weapon for unlawful purpose, resisting arrest, aggravated assault on a law enforcement officer, possession of dum-dum bullets, illegal possession of an extended magazine, and attempted disarming a law enforcement officer. He was remanded to the Camden County Jail.

10/1/21 While on patrol in the area of the 100 block of New Broadway an officer observed a female who was known to have active warrants for her arrest. After placing the female under arrest the officer located a bundle of copper mesh, an empty blue wax fold, an empty plastic vial with white residue, and an empty blue plastic transparent plastic bag containing a white residue. Natalie Nicole Diaz, 41, of Westville was charged with possession of drug paraphernalia. She was released with a pending court date.

10/3/21 During the course of a motor vehicle crash in the area of Rt. 130 and Browning Ln officers believed that one of the drivers was under the influence. After conducting field sobriety tests officers placed the driver under arrest. Donna Marie Payne, 61, of Philadelphia was charged with operating a vehicle under the influence of liquor and/or drugs, she was also issued other motor vehicle summons and released to a sober adult.

10/4/21 Officers responded to the Wawa for a theft of gas. A gray Hyundai Sonata driven by a black male and with a white female passenger left the store without paying for \$55 of gas. The vehicle was last seen traveling north on Rt. 130.

10/4/21 Officers responded to the Wawa for a shoplifting. A white male in his 30s with short black hair wearing a face mask, and a grey hoodie walked into the delivery area and stole 6 cases of 20oz Red Bulls valued at \$400. The male is seen getting into a dark colored Hyundai Sonata with black rims with a possible Florida licenses plate.

10/5/21 Officers responded to the Wawa for a theft of gas. The vehicle is described as a black Ford pickup truck that received \$118 of gas. The vehicle in question was found to be a stolen motor vehicle out of Franklin Twp.

10/5/21 Officers responded to the Shoprite parking lot for a criminal mischief report. Officers learned that the victim had an incident with another motorist over a parking space and when she came out from shopping one of her tires was flat. After reviewing the surveillance footage officers observed the male who had the confrontation with the victim walk up to the victim's, vehicle with something in his hands and then make a stabbing motion near the tire. Officers

identified the male as Michael D. Reider, 59, of Mount Ephraim. He was charged with the criminal mischief.

10/7/21 Officers responded to the Wawa for a shoplifting. A white male wearing a black sweatshirt, blue ripped jeans, black shoes and a black Nike hat stole approximately \$241 worth of merchandise, including two cartons of Newport cigarettes. He then fled the store in an unknown vehicle.

10/11/21 Officers responded to the empty building in the Brooklawn Shopping Center where Eve's Furniture was located. An unknown actor removed metal from outside of the building with a pickup truck. Anyone with information regarding this incident please contact Brooklawn Police.

10/13/21 During the course of a motor vehicle stop regarding the burglary from the Old Eve's Furniture on 10/11/21 officers located the suspect in the passenger seat of the vehicle. When the driver pulled the vehicle over he exited the vehicle and the passenger jumped into the driver's seat and sped off from the scene. The male who exited the vehicle was identified as Braxton Carne Moore, 27, of Sicklerville. Through further investigation, he was found to have 2 warrants for his arrest. Also located in his possession was 9 wax folds of heroin. He was charged with possession of CDS and released on a summons. The vehicle that fled has not been located at this time.

10/14/21 Officers responded to the Wawa for a theft of gas. A black male driving a white Chevy Silverado left the store without paying for \$93 of gas. He was last seen on Rt. 130 North.

10/14/21 Dispatched to the Rite Aid for a shoplifting. A black male in his 40s-50s in a blue hat, black shirt removed approximately 4 pairs of sunglasses and placed them in his backpack. The sunglasses were valued at \$20 each. The male fled the store on a bicycle towards Bellmawr.

10/14/21 Dispatched to the T-Mobile for a shoplifting. Employee stated that earlier in the day a black male wearing a blue hat and black shirt took an iPhone valued at \$400 from the store. The employee did not realize the phone was taken until almost 3 hours after the incident.

10/16/21 Dispatched to the Dollar Tree for a shoplifting. Employee called and stated that a black male in a rain jacket, with orange shorts stole frozen food items by concealing them underneath his jacket. He then fled on a mountain bike. Officers searched the area but were unable to locate the male.

10/17/21 Michelle Sewell, 53, of Westville was stopped for a motor vehicle violation in the area of Rt. 130 and Kings Hwy. During the course of the stop Sewell at first lied to the officer regarding her actual name. She was placed under arrest after the officer was able to obtain her real information. She was found to have active warrants for her arrest. She was charged with hindering and released with new court dates for her outstanding warrants.

10/18/21 Dispatched to the Shoprite for a female who attempted to shoplift by not scanning items at the self-checkout line. Brooke Julia Szymanski, 31, of Mt. Ephraim was placed under arrest and also found to have 2 warrants for her arrest. During the course of the arrest Szymanski

was found to have used this method of shoplifting 13 other times at the Shoprite. She was charged with 14 counts shoplifting and released with new court dates.

An assisting Bellmawr Police Officer located the male matching the description. Corey Michael Davis, 21, of Somerdale was placed under arrest. The officers located an oxycodone pill and 2 wax folds of heroin on Davis. He was charged with shoplifting, possession of drug paraphernalia and 2 counts possession of CDS and released on a summons.

10/23/21 Mauricio Bravo-Lucero, 36, of Rahway was stopped for a motor vehicle violation in the area of the East Traffic Circle. During the course of the stop the accused was found to be operating the motor vehicle under the influence of alcohol and/or drugs.
