

December 2021 Press Releases:

12/1/21- Wawa reported a theft of \$15 of gas. During the course of the investigation the suspect was identified. Thomas Edward Deitz, 29, of Vineland was charged with theft and a summons was mailed to his address.

12/1/21- An off-duty Mount Ephraim Police Officer observed a theft of gas from the Conoco Gas Station. The officer followed the suspect vehicle and the driver was stopped in Gloucester City and placed under arrest. Jacob Noah Dixon, 22, of Barrington received \$40 of gas and fled the scene.
