

February 2022 Press Releases:

2/3- Officers responded to the Swap Shop for a motor vehicle who struck a pedestrian. The vehicle had fled the scene before officers got on scene. Through the investigation the identity of the driver was discovered. Chester T. Harden 2nd, of Gloucester City was charged with Assault by Motor Vehicle and issued numerous motor vehicle summonses.

2/10- John Matthew Koncewicz, 50, of Woodbury, was stopped for a motor vehicle violation in the area of Rt. 130 South. Koncewicz was found to have a warrant for his arrest. He was also found to be in possession of clear plastic bag containing a white residue and a blue vial containing a white residue both commonly used to package narcotics. He was placed under arrest and charged with possession of drug paraphernalia. He was released with pending court date.

2/13- Officers responded to the Wawa for a stolen motor vehicle. The victim left her vehicle running in the parking lot and entered the store. A review of the surveillance camera revealed a male walk from the Rite Aid parking lot, open the driver's side door and he immediately drove off with the vehicle. surveillance, Boykin pull next to the victim's vehicle, get out of his vehicle, and then entered the back of the victim's vehicle which was left unlocked. Boykin then climbed into the third row of the victim's vehicle. Sometime during the victim's travel, Boykin climbed over the seats and punched the victim in the back of the head. After the vehicle stopped, he fled on foot. Boykin was arrested and charged with burglary and simple assault. He was remanded to the Camden County Jail.
