

January 2022 Press Releases:

1/2- Unknown suspect(s) entered one of the basements at the Brooklawn Norse Apartments and stole a backpack leaf blower and two drill batteries sometime between 12/30/21-1/2/22.

1/7- Officers responded to the Wawa for a stolen motor vehicle. The victim left his vehicle unlocked and running in the parking lot. When exited the Wawa, and only about 4 minutes later, his vehicle was gone. After reviewing the surveillance footage, two black males are seen exiting a silver vehicle and entering the victim's vehicle, which was a white Mazda. They then drove off with the vehicle toward Browning Lane.
