## March 2022 Press Releases:

- 3/1/22- Officers responded to the Wawa for a theft of gas. A red Toyota with a Pennsylvania plate, driven by a white male with a white female passenger received \$17 of gas. After receiving the gas, the male drove off after the attendant removed the nozzle.
- 3/3/22- Officers responded to the Brooklawn Food Mart for a report of a counterfeit bill. A white male wearing a black jacket, black beanie hat, dark pants, grey gloves, and a blue mask used the fake bill after asking for five \$20 lottery tickets.
- 3/4/22- Tracy Scott Waldhelm, 50, of Camden was stopped for a violation while riding his bicycle in the area of the 500 block of New Broadway. During the course of the stop, Tracy was found to have multiple warrants for his arrest. Also in his possession was a crack pipe. After losing the suspect for a short period of time, he was finally apprehended in a Bellmawr residence backyard, inside a shed. Shaoquna Rishen Williams, 25, of Camden was charged with shoplifting, resisting arrest, criminal mischief (kicking and damaging processing desk) and hindering. While in custody, it was determined that Williams was the suspect of multiple vehicle thefts at the Wawa and shopping center in Brooklawn. He was also charged with 4 counts of motor vehicle theft. Williams also had a no-bail warrant out of Camden City. He was eventually remanded to the Camden County Jail.
