### COMMENTS FROM MAYOR/COUNCIL/DEPARTMENT HEADS:

Public Works Assistant Superintendent M. Ostrom discussed the new meter program and stated mailers were going out to residents. Chief Shamus Ellis thanked Mayor and Council for a great night for the Police Department. Council member P. Moses stated a total of 6 trees will be planted shortly and thanked M. Ostrom for his help. Council member Moses also discussed speeding issues that were brought to his attention. Mayor Branella asked Council member Moses to follow through with possible solutions. Council member P. McConnell detailed the plans for a 4<sup>th</sup> of July parade and the event for the day. Council President J. McCleary stated Borough Homes are at 100 percent capacity and that she is pleased with repairs and updates being done. Council President McCleary also stated the weeds on the bulkhead where the new flowers were installed need to be addressed. Council President McCleary discussed the offensive graffiti on the building near Rolferrys. M. Ostrom stated the building will be painted after the 4th of July. Council member Granstrom requested access to Police cameras due to the suspicious activities he feels is occurring on Timber Blvd near the waterfront. Tim Higgins stated he would have to check the legalities of having access to the police cameras. Chief Ellis stated to please call 911 and a call would be sent to check out the situation. Council member Clotworthy gave an update on the progress of the playground and stated he would share the quotes although not final with Council President McCleary. Council member Mevoli congratulated Council President McCleary, Council member McConnell and Council member Moses on their recent primary election win. Council member Mevoli also discussed the 4th of July event and precautions that need to be in place and requested a letter from Mayor and Council go to all departments with a list of all events and what is expected from each department. Deputy Clerk T. Twichell discussed the fireworks event and gave details of the shred event. Administrator Giles discussed the cyber security training through JIF that needs to be completed and the deadline for it to be completed. Ryan stated a capital ordinance for \$300,00 would be on the agenda for the meeting for the purchase of the church property.
