

July 2022 Press Releases:

7/1- Wawa reported a black Jeep with a Florida License Plate received \$93 worth of gas and left without paying. The driver was a black male with a black male in the passenger seat. The vehicle fled in an unknown direction.

7/4- Officers responded to the 200 block of 5<sup>th</sup> Street for a report of vandalism and theft. An unknown actor broke into the victim's vehicle and removed numerous items from inside the vehicle. The actor also stole a bicycle, dismantled another bike, and cut the battery out of a power wheel. This occurred sometime overnight.

7/6- Officers responded to the 200 block of Paris Ave for a vehicle that was broken into. Sometime between 9pm-9am, an unknown actor entered the victim's unlocked vehicle and took change from the center console and rummaged through the glove box. Another vehicle on the 200 block of Horton Ave was also broken into overnight. The vehicle's doors were also left unlocked.
