June 2022 Press Releases:

- 6/1- A male left his vehicle running with the keys in the ignition and went into Wawa. When the male exited the store, his vehicle was gone. An unknown actor entered the victim's vehicle and drove away with the vehicle.
- 6/1- Officers were dispatched to Rite Aid for a shoplifting. Two males; one black male was wearing a jean jacket with a furry collar and the other was wearing a dark jacket. The two suspects concealed \$1,996.82 worth of over-the-counter medicine.
- 6/2- Officers were dispatched to Rite Aid for a shoplifting. A white male, wearing a black hoodie and blue jeans, with a white female, wearing a gray hoodie and gray leggings, used a red Wawa bag, and placed over \$200 worth of skin/beauty items and electronics into the bag and left the store.

The male put the vehicle in drive and accelerated away from the pumps towards the building, sending the group he was fighting with running away from him to avoid the traveling vehicle. The male ran the vehicle into another parked vehicle, belonging to the other group. The male then exited the vehicle he was driving and fled the scene on foot. This was captured on Wawa's video surveillance.
- 6/7- Officers responded to the Penske Parking Lot for two catalytic converters stolen from parked trucks that were in the lot. This occurred sometime between June 3rd June 5th.
