

**ORDINANCE # 16-22**

**ORDINANCE OF THE BOROUGH OF BROOKLAWN,  
COUNTY OF CAMDEN, STATE OF NEW JERSEY  
AMENDING CHAPTER 141, VEHICLES AND TRAFFIC, IN  
THE CODE OF THE BOROUGH OF BROOKLAWN**

**BE IT ORDAINED** by the Borough Council of the Borough of Brooklawn, County of Camden, and State of New Jersey amending Article XII., Schedules, in Chapter 141, Vehicles and Traffic, in the Code of the Borough of Brooklawn, as follows:

Intersections.**

The following described intersections are added to the list of intersections already designated as stop intersections, and stop signs shall be installed as follows:

<b>Intersection</b>	<b>Stop Sign on</b>
Second Street, Lake Avenue, Center Street and the entrance/exit to the Brooklawn Community Center	4-way

The following described intersections are deleted to the list of intersections already designated as stop intersections, as follows:

<b>Intersection</b>	<b>Stop Sign on</b>
Second Street and Center Street	Center Street
Center Street and Second Street	East Corner of Center Street

**ARTICLE II.**

All Ordinances contrary to the provisions of this Ordinance are hereby repealed to the extent that they are inconsistent herewith.

**ARTICLE III.**

This Ordinance shall take effect upon passage and publication according to law.
