April 2023 Press Release:

4/1/23- Officers responded to the Shoprite for a shoplifting. Denis N. Rivers, 41, of Camden, loaded a shopping cart with items totaling \$356.01. She then attempted to leave the store through the entrance doors. She was placed under arrest and charged with Shoplifting. She was released with a Superior Court Date.

4/1/23- Officers responded to the Wawa for a shoplifting. Aaron Michael Collins, 31, of Woodstown concealed \$197.53 worth of candy. Collins was placed under arrest and charged with Shoplifting and Defiant Trespass since he was arrested for shoplifting from Wawa on a prior date.
