

March 2023 Press Releases:

3/3/23- Officers responded to the Ride Aid for a shoplifting in progress. Peter Talianetti, 62, of Bellmawr concealed \$42.00 worth of merchandise in his duffle bag and attempted to exit the store. He was placed under arrest and charged with Shoplifting and released with a municipal court date.

3/3/23- Officers responded to the Rodeway Inn for a report of a theft. A black male slid his arm under the window glass at the desk and removed the laptop from the desk. The male then got into an unknown white vehicle with another male and fled the area.

3/4/23- Officers responded to the Rite Aid for a shoplifting. Kevin Short, 35, of Woodbury attempted to conceal a supply lock box in his jacket. Short was placed under arrest and charged with Shoplifting. He was released with a pending municipal court date.

3/4/23- Officers responded to the Empire Sports Bar for a fight. Officers located the victim who was bleeding from his head. The victim was transported to the hospital for medical evaluation.
