May 2023 Press Releases:

- 5/2 Officers were called to the Wawa for a shoplifting. The accused had fled on foot north on Rt. 130. The suspect was located on Market Street in Gloucester City. Angel Luis Santos, 38, of Camden was arrested, and officers located 32 Red Bulls and 6 Monster Energy Drinks totaling \$160.00 in his backpack.
