

August 2023 Press Releases:

8/4- Officers responded to Shoprite for a black male and black female who were shoplifting. The pair, who had two young children with them, loaded up two shopping carts full of merchandise. Officers on scene watched the surveillance cameras as the two distracted the cashier, scanning in some items, and then concealing others in the reusable bags while the cashier wasn't paying attention. The two then exited the store. Brooklawn Police along, with Gloucester City and Mount Ephraim Police, stopped the two once they exited the second set of doors. Jordan Dean McCormick, 22, of Camden and Zainab V. PaddyFootJones, 33, of Camden were placed under arrest. McCormick was charged with shoplifting and remanded to the Camden County Jail. The children were turned over to their uncle until their mother was released. PaddyFootJones was charged with shoplifting and released on a summons.

8/4- An officer came across a disabled U-Haul truck on Rt. 130. Through further investigation the truck was found to be stolen. The driver Joseph A. Owens, 66, of Westville was placed under arrest. He was found to have 2 warrants for his arrest. He was charged with Receiving Stolen Property and released on a summons and with new court dates for his warrants.

8/5- Officers responded to CSL Plasma for possible vehicle burglaries. A black male wearing a grey shirt, and blue scrub-style pants entered 2 separate vehicles in the parking lot. Using the surveillance footage from the parking lot and from CSL Plasma a suspect was identified. Tyrone J. Tuten, 25, of Camden was charged with burglary, theft, and criminal attempt burglary. He was later served his summonses through the mail.

8/8- Officers responded to Wawa for a well-being check on a male on a motorcycle. During the course of the investigation Raymond DiMatteo, 34, of Bellmawr was found to be a wanted person out of Gloucester County's Prosecutor's Office and a no bail warrant out of Bellmawr. DiMatteo was placed under arrest and found to be in possession of 4 oxycodone pills. He was placed under arrest and charged with hindering and possession of CDS. He was turned over to Bellmawr PD to be processed and remanded to the Camden County Jail.

8/11- Officers responded to Shoprite for two males loading a shopping cart attempting to shoplift. Jose Maunel Collazo, 34, of Woodbury and Nelson William Hernandez, 21, of Philadelphia walked out of Shoprite with \$452.00 of items without paying. They were placed under arrest and both were charged with shoplifting and released on summonses.

8/12- Around 0330 hours two males entered a vehicle on the 200 block of New Broadway. The two actors were able to start the vehicle and fled the area with it. The owner followed the vehicle into Camden City but lost it in the city. It was determined later that the suspect arrived in the area in a stolen van that they left on the 200 block of Chestnut St. The van was towed and the owner was contacted.

8/14- Officers responded to Wawa for a black male in his late 40s, Eagles hat, white shirt, and orange shorts who attempted to pass counterfeit bills. When the employee did not take the money, the male placed the cigarettes into his pocket and fled the store in an unknown vehicle.

8/16- A brown or maroon van/SUV with two black males in their 20s went to the Conoco Gas Station and the driver asked for \$20.00 of gas. Once the gas was done the male fled down Rt. 130. The attendant was able to get a tag and the vehicle came back stolen out of Philadelphia. Officers were unable to locate the vehicle.

8/17- Officers responded to Rite Aid for a male who attempted to pay with counterfeit money. The male distracted the employee with the fake bills, then was able to turn the touch screen to him and upload \$500.00 into a cash app account. He then fled the store in an unknown direction. The bills were taken and sent to the U.S. Secret Service.

8/21- Officers responded to Shoprite for a shoplifter in custody. Loss Prevention had Jasmine L. Holland, 37, of Blackwood concealing over \$250.00 on 4 different occasions from Shoprite. She was placed under arrest and charged with 4 counts of Shoplifting. She was charged accordingly and released on summonses.
