

July 2023 Press Release:

7/2- A white male in his 20s wearing a black sweatshirt and brown pants placed approximately \$70.00 of merchandise from Shoprite into his front sweatshirt pocket. The male then fled on foot prior to the officers' arrival. Using the surveillance footage from Shoprite a suspect was identified. Derek William Barnes, 39, of Camden was charged with shoplifting and defiant trespass. The charges were mailed to his address.

7/2- Gary Clayton Simmons, 58, of Brooklawn was in Shoprite and concealed two steaks valued at \$24.00 in his pants while in the bathroom. He fled the store but was later found at the Rodeway and placed under arrest. He was charged with shoplifting and released on a summons.

7/2- A white male in his 30s wearing a black Adidas jacket and blue jeans placed \$24.00 worth of items into a reusable bag and left the store. The employee was able to get the vehicle's license plate and using their surveillance footage, were able to identify the suspect. Francis A. Glassmire, 32, of Gloucester City was charged with shoplifting and served through the mail.

7/3- Francis A. Glassmire, 32, of Gloucester City shoplifted from the Wawa again. This time for \$30.00. He was charged again with shoplifting, put on a summons, and served through the mail.

He was placed under arrest. Gopsill was charged with possession of CDS and released on a summons with a Superior Court Date.

7/9- Officers responded to Rite Aid for a shoplifting. A black female with a black and white headband and flip flops stole \$285.00 of make-up. The female left on foot and was last seen towards Wawa.

7/14- Theresa Lee Brooks, 63, of Gloucester City was found to be a wanted person out of the Gloucester County Prosecutor's Office. During the investigation she was found to be in possession of 16 suboxone films. She was placed under arrest and charged with possession of CDS and failure to properly dispose of CDS. After the situation was over the male half continued yelling causing a scene while
