December 2023 Press Releases:

12/1- Alexis Centeno, 43, of Camden, was identified as the suspect of a shoplifting from November 29 at the Shoprite. Centino concealed \$407.79 worth of batteries in a reusable shopping bag and walked through an empty checkout line. Centeno was charged with shoplifting and was mailed a summons.

12/1- Officers responded to the Rite Aid for a shoplifting. A black female, approximately 30-40 years of age, wearing a black jacket, gray sweatshirt, and a mask, concealed \$433.00 worth of deodorant in a reusable shopping bag and fled the store on foot. On 12/30, a suspect was identified in this shoplifting. Yasheka Khusana Dunmore, 45, of Philadelphia, was charged with the shoplifting, and a summons was mailed to her residence.

She was remanded to the Camden County Jail.
