

September 2023 Press Releases:

9/1- Officers responded to Planet Fitness for an unknown white male who entered the employee locker room, went through the victim's bag, and removed a wallet. The investigation is ongoing.

9/3- A black female driving a Hyundai with window tint received \$67.00 worth of gas from Wawa and fled the store without paying.

9/4- Officers responded to Wawa for two vehicles that left without paying for gas. The first vehicle was a grey Dodge Charger with a Pennsylvania tag, which got \$75.00 worth of gas. The driver was a Hispanic male with a neck tattoo. The second was another Pennsylvania tag of unknown make or model. A passenger of this vehicle exited the vehicle and pumped \$34.91 worth of gas into it. Both tags were reported stolen out of Philadelphia.

9/5- An unknown black male wearing a red shirt, blue jeans, and tan shoes, with a bandage on his left elbow, stole 16 Red Bulls from Wawa. He was last seen on foot walking towards the shopping center.
