February 2024 Press Releases:

2/2- An officer responded to Shoprite for a report of a theft from the rear of the building. An unknown male was observed placing 2-liter bottle containers into his truck on three separate occasions totaling \$700.00. The company that supplies the containers sent an employee to the store, and through video surveillance, a suspect was identified. David E. Rankins, 60, of Glassboro, was charged with Theft. A summons was mailed to his residence.

2/8- An unknown Hispanic male in his late 20s or early 30s, approximately 5'9" tall, medium build, wearing a Bengals Jersey, black winter coat, black pants, and black shoes, placed almost \$900.00 worth of merchandise into a reusable shopping bag and fled the store.
