April 2024 Press Releases:

4/4- Sometime overnight, an unknown actor(s) cut the lock off the fence of the PSE&G Plant. The actors also cut the lock on the trailer inside the lot. Nothing was reported to be missing at this time.

4/5- An officer stopped a male at Kings Hwy and Browning Ln for failure to use the crosswalk. During the course of the pedestrian stop, the male was found to have an active warrant for his arrest.
