# ORDINANCE OF THE BOROUGH OF BROOKLAWN, COUNTY OF CAMDEN AND STATE OF NEW JERSEY AMENDING CHAPTER 84, FIRE PREVENTION, IN THE CODE OF THE BOROUGH OF BROOKLAWN

**BE IT ORDAINED** by the Mayor and Borough Council of the Borough of Brooklawn, County of Camden, and State of New Jersey, that Chapter 84, Fire Prevention, is hereby amended to the Code of the Borough of Brooklawn, as follows:

# ARTICLE I. SECTION 84-8

Required inspections and fees;

In addition to the inspection and fees required pursuant to the Act and the regulations of the Department of Community Affairs, the following additional inspections and fees shall be required:

A. Inspection and fee schedule for all buildings as defined in the Uniform Fire Code N.J.S.A. 52:27D-192 et seq. as amended and not classified as life hazard buildings in accordance with N.J.A.C. 5:70.24

- B. Non-Life Hazard Government and Not for Profit Building
  - 1. Non-life government and not for profit buildings / organizations shall not be exempt from obtaining a Fire Permit but shall be exempt from paying the fee for the inspection and Fire Safety Permit. (A Letter of Determination from the IRS shall be on file with the fire officials' office to ensure not for profit status).
- C. Any building owner who fails to submit annual registration fees within thirty (30) days of receipt shall be fined double the amount of the initial registration fee.

  Permits: requested with less than 48 hours of the event shall be charged double the registration amount (not annual permits fees for business owners within the Borough).

### ARTICLE II.

All Ordinances contrary to the provisions of this Ordinance are hereby repealed to the extent that they are inconsistent herewith.

#### ARTICLE III.

This Ordinance shall take effect upon passage and publication according to law.
