ORDINANCE OF THE BOROUGH OF BROOKLAWN, COUNTY OF CAMDEN, STATE OF NEW JERSEY AMENDING CHAPTER 141, VEHICLES AND TRAFFIC, IN THE CODE OF THE BOROUGH OF BROOKLAWN

BE IT ORDAINED by the Borough Council of the Borough of Brooklawn, County of Camden, and State of New Jersey amending Chapter 141, Vehicles and Traffic, in the Code of the Borough of Brooklawn, as follows:

ARTICLE I. ARTICLE II. SECTION 141-7.2

Permit parking; exceptions to parking restrictions for certain residents; insignia required.

- A. The following shall constitute exceptions to the prohibitions set forth in Schedule II against parking between the hours of 9:00 pm and 6:00 am on both sides of Timber Boulevard between Pennsylvania Road and New Jersey Road, specifically parking spaces designated as #11 through #15 on the East side of Timber Boulevard; provided, however, that no motor vehicle shall be permitted to be parked in one of the designated parking spaces for more than twenty-four (24) continuous hours:
- 1. Where the Borough Clerk is satisfied that the Brooklawn property owner making written application for the permission provided for in this Section and the following subsections has conclusively demonstrated both proof of ownership of and domicile in a property within the Borough of Brooklawn, the Borough Clerk shall issue to such person an insignia authorizing such resident to park a motor vehicle owned or principally used by him/her in one of the parking spaces designated as #14 through #19 on the East side of Timber Boulevard, between the hours of 9:00 pm and 6:00 am. The Borough Clerk shall render a decision on said written

application within ten (10) days of the filing thereof. No more than ten (10) permits in total be issued under this Section.

- 2. Such insignia shall be issued for a period of one (1) year and shall be renewable upon the Borough Clerk being satisfied of the matters set forth in Subsection A.
- 3. Such insignia shall be displayed at all times upon the rearview mirror of the motor vehicle being parked, as permitted herein, so that the same shall be visible.
- 4. Any resident denied a permit may, within five (5) days of the denial of said request, file a written appeal of said denial to the Borough Public Safety Committee, which will decide each case on its merits and render a written decision within fifteen (15) days of the filing of said appeal.
- 5. Commercial vehicles with a gross vehicle weight (GVW) of 9,000 pounds or greater shall not be eligible for issuance of a parking permit under this Section.
- 6. No more than one permit shall be issued to a person who has demonstrated ownership of and domicile in a property within the Borough of Brooklawn, and who has been licensed to operate a motor vehicle by the State of New Jersey.
- 7. All permits granted thereafter shall be for a term of one (1) year, and the holders thereof must reapply for such permits annually.
- 8. There shall be no fee for each permit issued hereunder except as is set forth in Section 141-7.2(B)(7) of this Chapter.
- B. The following shall constitute exceptions to the prohibitions set forth in Schedule II against parking between the hours of 9:00 pm and 6:00 am on both sides of Timber Boulevard between Pennsylvania Road and New Jersey Road, specifically parking spaces designated as #1 through #10 on the West side of Timber Boulevard; provided, however, that no motor vehicle

shall be permitted to be parked in one of the designated parking spaces for more than twenty-four (24) continuous hours:

- 1. Hunting Licensee: a person who presents proof to the Borough Clerk of a valid hunting license issued by the State of New Jersey may submit a written application for the permission provided for in this Section and the following subsections, with the Borough Clerk issuing to such Licensee an insignia authorizing such Licensee to park a motor vehicle owned or principally used by him/her in one of the parking spaces designated as #1 through #13 on the West side of Timber Boulevard, between the hours of 9:00 pm and 6:00 am. The Borough Clerk shall render a decision on said written application within ten (10) days of the filing thereof.
- 2. This permit shall be valid from September 1 of the calendar year or the date of its issuance, whichever is later, and shall expire on January 31 of the subsequent calendar year.
- 3. Such insignia shall be displayed at all times upon the rearview mirror of the motor vehicle being parked, as permitted herein, so that the same shall be visible.
- 4. Any person denied a permit may, within five (5) days of the denial of said request, file a written appeal of said denial to the Borough Public Safety Committee, which will decide each case on its merits and render a written decision within fifteen (15) days of the filing of said appeal.
- 5. Commercial vehicles with a gross vehicle weight (GVW) of 9,000 pounds or greater shall not be eligible for issuance of a parking permit under this Section.
- 6. No more than one permit shall be issued to a person who has presented proof to the Borough Clerk of a valid hunting license issued by the State of New Jersey, and who has been licensed to operate a motor vehicle by the State of New Jersey.

7. There shall be a fee of Twenty-five (\$25.00) Dollars charged to persons who apply for a permit under this subsection. The fee to be charged to persons who apply for a permit under this subsection shall be waived if the person conclusively demonstrates both proof of ownership of and domicile in a property within the Borough of Brooklawn.

ARTICLE II. ARTICLE XII. SECTION 141-33 Schedule A: No Parking.

In addition to those described streets or parts of streets already listed in Schedule A, and in accordance with the provisions of Section 141-6 of this Chapter, no person shall park a vehicle at any time upon any of the following described streets or parts of streets:

ARTICLE III. ARTICLE XII. SECTION 141-34 Schedule B: No Parking Certain Hours.

In accordance with the provisions of Section 141-7, no person shall park a vehicle between the hours listed upon any of the following described streets or parts of street:

ARTICLE IV.

All Ordinances contrary to the provisions of this Ordinance are hereby repealed to the extent that they are inconsistent herewith.

ARTICLE V.

This Ordinance shall take effect upon passage and publication according to law.
