

**ORDINANCE #16-24**

**ORDINANCE OF THE BOROUGH OF BROOKLAWN,  
COUNTY OF CAMDEN, STATE OF NEW JERSEY  
AMENDING CHAPTER 112, PARKS AND RECREATION,  
IN THE CODE OF THE BOROUGH OF BROOKLAWN**

**BE IT ORDAINED** by the Borough Council of the Borough of Brooklawn, County of Camden, and State of New Jersey amending Chapter 112, Parks and Recreation, in the Code of the Borough of Brooklawn, as follows:

**ARTICLE I. SECTION 112-2 Prohibited conduct.**

While in public park or recreation area, all persons shall conduct themselves in a proper and orderly manner, and in particular, no person shall:

M. Construct, possess or use a rope or canvas bed, or comparable device, made from a similar material, that hangs either permanently or temporarily from a stand, two trees, or another support, commonly referred to as a “hammock.”

**ARTICLE II. SECTION 112-5 Violations; penalties.**

Any person(s) found to be in violation of the provisions of this Chapter shall, upon conviction thereof, be liable for penalties or any combination thereof as set forth in Chapter 1-15 of the Code of the Borough of Brooklawn, in the discretion of the Judge of the Municipal Court before whom such violation is heard and conviction made. Each day that a violation occurs shall be deemed a separate and distinct violation, subject to the penalty provisions of this Chapter.

**ARTICLE III.**

All Ordinances contrary to the provisions of this Ordinance are hereby repealed to the

extent that they are inconsistent herewith.

**ARTICLE IV.**

This Ordinance shall take effect upon passage and publication according to law.
