

July 2024 Press Release:

7/1- Officers responded to the Red Carpet Inn for a disturbance. The officers responded to a room and met a male. The male gave the officer a fake name. After a brief investigation, the male was identified as Steven Allan Williamson, 51, of Wenonah, and was found to be a wanted person out of Camden County Prosecutor's Office. He was placed under arrest, transported to headquarters, charged with Hindering, and remanded to the Camden County Jail.

7/9- During an investigation regarding an assault at the Rodeway Inn, Jemimah Angel Mims, 28, Camden, was found to be a wanted person out of Burlington County Sheriff's Office. Mims was placed under arrest, transported to headquarters, and remanded to the Camden County Jail.

7/13- Officers responded to Shoprite for a male who shoplifted. Todd Robin Lopez, 60, of Deptford, concealed \$27.80 worth of merchandise. Lopez was placed under arrest and transported to headquarters. Lopez was charged with Shoplifting and released on a summons.

Hausser was found to be in possession of one bag of crystal meth, one glass pipe used to smoke narcotics. He was transported to headquarters and charged with Possession of CDS, Possession of Drug paraphernalia, and Hindering. He was remanded to the Camden County Jail.

7/15- An unknown female shoplifted numerous items from the store. The suspect was wearing a black shirt and white pants. She stole approximately \$45 worth of merchandise. She was last seen getting into a black Lexus SUV.

7/15- Officers responded to the area of Pershing Rd for four (4) unidentified suspects wearing masks pulling on car door handles while walking down the street. The four (4) were followed by a black Nissan, which they jumped into when they did not get into any other vehicle to take on the street. The group did manage to enter some vehicles on the street and removed items from the unlocked vehicles. She was remanded to the Camden County Jail.

Using the surveillance footage, the registered owner's photo of the vehicle matched the female suspect from the video. Tajunae L. Fisher, 29, of Camden, was mailed a summons for Shoplifting.
