June 2024 Press Release:

6/1- Officers responded to the 100 block of Browning Ln for a report of an intoxicated person. While interacting with the intoxicated male, Donnell Anthony Mathes, 58, of Bellmawr, was found to be a wanted person out of the Camden County Prosecutor's Office.
