October 2024 Press Release:

- 10/2- Officers responded to Planet Fitness for a report of a theft from the men's locker room. The victim stated that his watch, valued at \$375.00, was stolen. The investigation is ongoing pending review of surveillance footage.
- 10/3- Officers responded to ShopRite regarding a report of a woman asking people for money. The woman, Michele Babich, 53, of Mantua, was charged with Begging under Borough Ordinance 113-3.
- 10/3- Officers responded to Planet Fitness for a report of a theft from the women's locker room. Four victims reported that their locks were cut, with one victim specifically stating her Michael Kors wallet was stolen. All victims reported the theft of their personal identifying information (PII). Surveillance footage showed a suspect described as a Black female wearing a pink shirt, pink yoga pants, and carrying a large pink bag. Further investigation revealed that the suspect had attempted to use a stolen debit card at the Walmart in Audubon.
- 10/4- Officers were dispatched to the Carnival Book Store for a report of a suspicious vehicle. The driver, identified as Frank Fattori, 43, of Camden, admitted to smoking crystal meth and PCP earlier in the evening. Field sobriety tests were conducted and Fattori was placed under arrest for driving while intoxicated (DWI). Subsequently, suspected crystal meth and Xanax were located in plain view inside the vehicle's dashboard. Fattori was charged with the following offenses: Operating Under the Influence of Liquor or Drugs Operation of a Motor Vehicle While in Possession of a Narcotic Possession of CDS Schedule I-IV, Possession of Drug Paraphernalia. He was released on a summons with a pending court date.
- 10/5- Officers responded to Dollar Tree for a report of shoplifting. The initial report described a Black male wearing all black clothing leaving the area on a bike heading toward ShopRite. The footage showed the male leaving on his bike toward ShopRite.
- 10/7- Officers were dispatched to Wawa for a report of shoplifting. Security footage showed the suspect's vehicle and its license plate. A check revealed that the registered owner matched the suspect observed in the video footage. The suspect, Kyeeth Smith, 33, of Willingboro, was charged with Shoplifting. A summons was issued and Smith was charged.
- 10/7- Officers responded to Verchio's Produce for a report of theft. An unknown Black female reportedly entered the store, ordered items from the deli, and left without paying. Management provided surveillance footage that captured the vehicle she left in, along with its license plate number. Investigation is ongoing.
- 10/7- Officers were dispatched to Wawa for a report of shoplifting. Upon reviewing security footage, it was observed that the suspect removed approximately \$20.00 worth of items and exited the store without paying. The license plate of the vehicle was obtained, and the registered owner matches the suspect from the video footage. A summons was issued for shoplifting.

An unknown white female, described as wearing an orange T-shirt, a light-colored ball cap, and a backpack, entered the store, placed items into a bag, and left without paying. Both individuals were transported to police headquarters. Desik was processed and released with new pending court dates. Sanders was processed and later transported to the Camden County Jail (CCJ).

10/22- Albert Shumakeris Jr., 40, of Brooklawn, facilitated a fight amongst juveniles. He was charged with Disorderly Conduct.
