

NOVEMBER 2024 Press Release:

11/3- Officers responded to Wawa for a report of a female and male sleeping in a vehicle. The driver was identified as, Kerri Stinger, 43, of Bridgeport. The male initially provided a false name but was later identified as Jahad Watson, 38, of Sicklerville. Officers observed empty wax folds inside the car. Both individuals were arrested. While attempting to identify Jahad at HQ, he damaged borough equipment. Kerri was later released on a summons for drug paraphernalia. Jahad was remanded to Camden County Jail on an NCIC warrant and charged with criminal mischief, violent behavior, hindering own prosecution, and failure to allow fingerprinting.

11/3- The victim reported that a male, identified to him as Marni, gave him \$700.00 in counterfeit money in exchange for a new iPhone 15 that the victim was selling. This transaction occurred near Wawa. The victim later discovered the money to be fake.

11/5- Officers responded to Wawa for a report of a shoplifting incident. A black female, approximately in her 50s, entered the store, stole several items, and then fled the scene in a Lexus bearing New Jersey registration. The investigation is ongoing, and a photo of the suspect has been updated to Facebook for identification purposes.

11/7- Officers responded to Wawa for a report of a shoplifting incident. A white female, wearing an orange jumpsuit, white shoes, and a black duffel bag, fled in a black Nissan with tinted windows and an unknown New Jersey registration.

11/7- Officers responded to Wawa for a report of shoplifting. Kyeeth Smith, 33, of Willingboro, entered the store wearing a green shirt and dark-colored shoes. He was observed selecting merchandise and walking past the point of sale without rendering payment. Smith was identified as the suspect due to two prior incidents of shoplifting at the same location. He was issued a summons for the current offense.

11/10- Officers were dispatched to the Conoco Gas Station for a theft of gas. Upon arrival, I spoke with the fuel attendant, who stated that an unknown black male, wearing a black face mask, had pumped \$21.87 worth of gas into his vehicle. The suspect was driving a blue sedan with a Pennsylvania registration. After filling up, the suspect pulled away from the pump without paying.

11/10- Officers responded to the Dollar Tree for a report of a shoplifting. A black male entered the store carrying a black reusable bag. The male proceeded to select a 24-pack box of Milky Way candy bars and fled on foot.

11/10- Officers responded to Wawa for a report of juveniles shoplifting. The individuals were identified from a previous shoplifting incident. After the incident, all parties fled the scene in a white Dodge Durango. The guardian, Amanda Quintana, 35, of Bellmawr, was advised not to return to the store due to trespassing. Upon review, Amanda Quintana was charged with trespassing.

11/12- Officers responded to the Conoco Gas Station for a report of a theft of gas. Upon arrival, the fuel attendant stated that a black Hyundai bearing NJ registration had pulled up to fill the vehicle with gas. While the vehicle was being filled, the driver removed the nozzle and fled the area, heading east towards the traffic circle. The total cost of the gas taken was \$16.

11/12- The victim called to report that his bicycle was stolen outside of ShopRite. Upon reviewing the surveillance footage, officers observed a white male, approximately in his 30s, wearing a gray/black hat,

green hoodie, gray sweatpants, and red/black shoes. The stolen bicycle was valued at \$550. Christoph Potts, 36, of Gloucester City, was identified as the suspect. He was charged with theft and issued a summons.

11/12- Officers were flagged down at the Dollar Tree by the victim, who reported that his \$300 skateboard was stolen while he was inside the store. The suspect is described as a male in his 30s, wearing a gray/black hat, green hoodie, gray sweatpants, and red/black shoes.

11/12- Officers observed Aminah Maloy, 40, of Camden, illegally dump two white trash bags into the Advanced Auto dumpster. Maloy was charged under Borough Ordinance 93-7 (Littering in Public Places Prohibited).

11/12- Officers responded to Wawa for a report of a shoplifting. The suspect left the area in a blue Chevrolet Impala. Through investigation, the suspect was identified as Kyeeth Smith, 33, of Willingboro. Smith was charged with shoplifting.

11/12- Officers responded to Wawa for a report of shoplifting. A white female, wearing a black hoodie, black sweatpants, and gray Uggs, carrying a black backpack, entered the store. She grabbed a handful of Reese's Peanut Butter Cups, valued at approximately \$20, and placed them into her backpack and entered a white van on the passenger side. The van, which had a Pennsylvania license plate, was driven by a male. The vehicle fled the area heading towards Bellmawr. A photo of the suspect has been posted on Facebook for identification purposes.

11/13- Officers responded to Wawa for a report of shoplifting. Tinisha Moore, 42, of Pine Hill, was arrested, charged, and released on a summons for shoplifting.

11/15- Officers responded to Wawa for a report of a woman who dumped trash into the parking lot. Monica Roohr, 33, of Camden, was identified and run for wants and warrants, revealing multiple active warrants. Roohr was arrested and found to be in possession of drug paraphernalia. She was charged with Borough Ordinance 113-5 and possession of drug paraphernalia and was released pending court.

11/16- Officers responded to Wawa for a report of shoplifting involving two black males. The suspects had stolen items from the store and left in a Ryder tractor trailer. A photo of the suspects has been posted on Facebook for identification purposes.

11/17- Officers responded to Rite-Aid for a report of shoplifting. A white male, wearing a green traffic vest and a dark-colored hoodie, entered the store and stole two cases of Ensure, valued at \$36.99 each. The suspect left the scene in a silver Dodge Charger. It was later discovered that the same individual also committed a shoplifting incident in Gloucester City. Photos of the male were posted on Facebook for identification purposes.

11/17- Officers responded to Wawa for a shoplifting. Stephen Brummell, 35, of Pennsville Kenyhan Green, 46, of Camden, Earl Hood, 61, of Camden were arrested, charged, and released pending court.

11/17- Officers responded to Wawa for a report of shoplifting. A white male was observed concealing items, exiting the store, and getting into a blue Subaru bearing NJ registration. Following an investigation, the male was identified as David Zelvis Jr., 34, of Wenonah. He was charged with shoplifting.

11/18- Officers responded to the Rodeway Inn for a reported theft. The victim stated that \$300.00 was missing from her room. An investigation is ongoing.

11/19- Officers responded to Wawa for a report of shoplifting. The suspect, described as a white male in his 30s, fled the store in a maroon Dodge Challenger with dealership paperwork taped to the passenger-side front windshield. Through further investigation, officers identified the suspect as Kobey Evans, 23, of Bellmawr. Evans later turned himself in and was arrested. He was charged with two counts of shoplifting related to incidents on 11/19 and 11/20 and released on a summons.

11/19- Officers responded to Wawa for a report of shoplifting. The suspect, described as a white male wearing a gray long-sleeve shirt, black hat, and jeans, was seen driving a gray Toyota Camry with a New Jersey registration. Following an investigation at the registered owner's residence, officers identified the suspect as Donald Berstler, 44, of National Park. Berstler was subsequently arrested, charged, and released on a summons.

11/20- Officers responded to Petco for a reported shoplifting. Three unknown individuals were observed taking several bags of dog food and a litter box, with a total value of \$570.00. The suspects fled the scene in a newer gray Ford Explorer bearing a New Jersey temporary tag. Upon investigation, the temporary tag did not match the Ford Explorer but was registered to a 1988 Honda Civic. A pickup and hold was issued for the vehicle. Photos of the suspects were posted on Facebook for identification purposes.

11/21- Officers responded to ShopRite for a report of shoplifting. Both suspects were stopped, and they provided false information. After obtaining their correct identities, both were found to have active NCIC warrants and were placed under arrest. Nicholas Supino-Delconte, 39, of Sewell, was found in possession of three glass pipes commonly used to smoke CDS. Christine Sanfelice, 33, of Pennsauken, was also arrested. Both suspects were transported to police headquarters, where they were processed and charged with possession of drug paraphernalia, shoplifting, and hindering apprehension. They were remanded to the Camden County Jail.

11/23- Officers were dispatched to The Empire Sports Bar for a report of a male refusing to pay his tab. Upon arrival, officers identified the individual as Joshua Ambrose, 30, of Marlton. Ambrose became combative and was subsequently arrested. He was transported to police headquarters, where he was processed and released on a summons for disorderly conduct.

11/26- Officers responded to Wawa for a report of shoplifting involving a white male driving a black Nissan Altima with a valid NJ registration. Following an investigation at the residence, the suspect, identified as Jeffrey Lytle, 64, of Bellmawr, was charged with shoplifting.

11/29- Officers responded to Wawa for a report of shoplifting. The suspect was observed leaving on foot toward the Rodeway Inn. Through further investigation, the suspect was identified as Carlos Vega, 36, of Camden. Vega was located at the motel and arrested. He was charged with failure to provide fingerprints and shoplifting. Additionally, he had a no-bail warrant out of Camden City. Vega was issued a summons for the charges and subsequently transported to Camden City Police Headquarters.

11/29- Officers responded to Conoco Gas Station for a reported theft of fuel totaling \$51.01. The victim stated that a gray four-door sedan, occupied by two unknown black males wearing all black clothing and black ski masks, pumped gas and left the station without paying.
