ORDINANCE OF THE BOROUGH OF BROOKLAWN, COUNTY OF CAMDEN AND STATE OF NEW JERSEY AMENDING CHAPTER 141, VEHICLES AND TRAFFIC, IN THE CODE OF THE BOROUGH OF BROOKLAWN

BE IT ORDAINED by the Mayor and Borough Council of the Borough of Brooklawn, County of Camden, and State of New Jersey, that Chapter 141, Vehicles and Traffic of the Code of the Borough of Brooklawn is hereby amended as follows:

ARTICLE I. ARTICLE XII. SECTION 141-52.1 Schedule U: Handicapped Parking Zones

In accordance with the provisions of Section 141-10, the following parts of streets described in this section of this Chapter are hereby added to the list of designated parts of streets authorized for designation, pursuant to N.J.S.A. 39:4-197.6, as restricted parking spaces for use by persons displaying on their vehicle a windshield placard or wheelchair symbol license plates issued by the New Jersey Division of Motor Vehicles, pursuant to N.J.S.A. 39:4-204 et seq.:

ARTICLE II.

All Ordinances contrary to the provisions of this Ordinance are hereby repealed to the extent that they are inconsistent herewith.

ARTICLE III.

This Ordinance shall take effect upon passage and publication according to law.
