

February 2025 Press Release:

2/3 – Renee Campbell, 49, of Brooklawn, was charged with Disturbing the Peace after she kicked over a trash can near her neighbor's front lawn.

2/5 – Officers responded to Wawa in Brooklawn for a report of past shoplifting. The store manager reported that Scott Dunda Jr., 33, of Brooklawn, failed to pay for coffee and breakfast sandwiches on 2/3 and 2/4. Dunda was placed under arrest, transported to headquarters, processed, charged with Shoplifting, and released on a summons.

2/6 – A female suspect exited the Wawa after paying for \$20 worth of items but failing to pay for an additional \$37.52. Surveillance footage was shared on the Brooklawn Police Facebook page. On March 17th, Sonja M. Kielt-Turner contacted police, identified herself as the suspect, and admitted to scanning the unpaid items. Her identity was confirmed via video footage and driver's license. Kielt-Turner was charged with Shoplifting.

2/8 – Officers were dispatched to Wawa in Brooklawn for the removal of Aaron Tice, 51, of Westville, who had previously been trespassed from the property. Tice was located outside the store, placed under arrest, and transported to headquarters. He was processed and released with a copy of his summons.

2/11 – Officers were dispatched to Wawa for a reported shoplifting. The store manager advised that a male suspect took several food items and exited without paying. The suspect was identified through surveillance footage as Kyeeth Smith, 33, of Willingboro, who had been previously identified in prior shoplifting incidents. Charges were mailed.

2/12 – Officers responded to Wawa in Brooklawn for a report of shoplifting. The suspect, Kyeeth Smith, 33, of Willingboro, fled on foot toward the Rodeway Inn. Officers located Smith entering a room at the motel, where he was taken into custody without incident. Smith was transported to headquarters and found to have an active ACS warrant out of Mount Laurel PD for \$750. He was processed, issued a summons for shoplifting, and released with a signed ROR.

2/13 – Officers responded to ShopRite for a shoplifting report. Laurie Hogan, 46, of Bellmawr, a former employee, was observed loading a cart with multiple Red Bulls and attempting to exit through the entrance vestibule. Loss prevention recovered the items before Hogan fled the scene. She was charged with Shoplifting, and a summons was mailed to her last known address.

2/15 – Wayne Wren, 38, of Sewell, and Ashley Naphy, 36, of Sewell, were involved in a shoplifting incident at Rite-Aid. The suspects filled a blue bag with items and attempted to conceal them in the store's bathroom, but were stopped by employees. They fled the store with \$57.78 worth of merchandise after the store manager recovered \$234.66 in stolen items. Wren and Naphy were identified and later matched the description of the suspects fleeing the scene in a blue pickup truck registered to Wren.

2/16 – Clarence Davis, 54, of Paulsboro, was charged with shoplifting after attempting to steal \$343.72 worth of mouthwash, Ensures, and Dove soap from ShopRite. Davis fled the scene in a blue Ford Focus, and after reviewing surveillance footage and coordinating with local police, he was identified. A summons for the charges has been mailed to Davis.

2/16 – Officers were dispatched to ShopRite in Brooklawn for a report of shoplifting. The suspect, identified as Jasiah Samuel Brooks, 22, of Sicklerville, was seen entering a vehicle wearing a green jumpsuit. Officers instructed him to exit the vehicle, but he refused multiple commands and became non-compliant. Additional officers were called to assist. Brooks eventually exited the vehicle but continued to resist. He was placed under arrest, charged with Shoplifting and Resisting Arrest, and released on a summons.

2/16 – Officers responded to ShopRite in Brooklawn for a report of a male yelling, cursing, and threatening to fight customers and employees. The individual, identified as Leif Jaishon Smith, 45, of Monroeville, continued his disruptive behavior upon police arrival. Smith was placed under arrest for breach of peace, transported to headquarters, and issued a citation.

2/17 – Officers were dispatched to ShopRite in Brooklawn for a report of shoplifting. The suspect, Brian Thomas Richardson, 45, of Gloucester City, was stopped by loss prevention after attempting to exit the store with a cart of unpaid merchandise. Staff reported Richardson had also shoplifted earlier the same day, with the total value of both incidents totaling approximately \$710.00. Richardson was placed under arrest, and during a search incident to arrest, officers located drug paraphernalia in his pocket and bag. He was transported to police headquarters, processed, charged with Shoplifting and Possession of Drug Paraphernalia, and released on a summons.

2/17 – Officers responded to Wawa for a reported shoplifting. The employee provided video footage showing Michael Bramell, 34, of Gibbstown, entering the store, placing multiple Red Bull cans into a plastic bag, and leaving without paying. He then entered his vehicle and left the area. Using the vehicle registration, officers identified Michael Bramell as the registered owner, matching the image from Wawa's surveillance cameras. Bramell was charged with Shoplifting, and a summons was mailed to his address.

2/17 – Dominique T. Bruce, 32, of Haddon Township, and James Boyce, 32, also of Haddon Township, were charged with shoplifting stemming from two separate investigations involving the theft of approximately \$278.00 worth of merchandise from Wawa. Both individuals were identified and charged accordingly.

2/17 – ShopRite reported that Laurie Hogan, 46, of Bellmawr, entered the store and placed \$14.00 worth of food items into her purse before leaving without paying. Hogan, a former employee, was identified by store staff. She was charged with Shoplifting in connection with this incident.

2/18 – Officers were flagged down at Wawa in Brooklawn for a reported shoplifting. The suspect, Rayanna Volpe, 29, of Burlington, allegedly stole two breakfast sandwiches. A warrant check revealed multiple active ACS warrants totaling \$2,500.00. Volpe was placed under arrest, and during a search incident to arrest, officers located three glass pipes and two empty blue wax folds in her purse. She was charged with Possession of Drug Paraphernalia and released on a summons.

2/18 – An officer observed a shoplifting in progress at Wawa in Brooklawn involving Anthony Palumbo, 49, of Bellmawr, who exited the store without paying for two sodas. He was escorted back inside, where his friend, Linda Gilfillan, 46, of Bellmawr, paid for the items. Palumbo was detained and found to have an active \$500 warrant out of Bellmawr. He was charged with disturbing the peace and issued a summons by mail. While officers were addressing Palumbo, Gilfillan became disorderly, using offensive

language and gestures after being asked multiple times to leave the store. She was placed under arrest, transported to headquarters, processed, and released on a summons for Disorderly Conduct.

2/19 – During a motor vehicle stop in Brooklawn, passenger Amanda Marie Watson, 35, of Lindenwold, was found in possession of suspected heroin and drug paraphernalia. A probable cause search of the vehicle revealed the driver, Brandon Tyler Clour, 31, of Salem, to be in possession of drug paraphernalia and a stolen bag of Red Bull taken from Wawa. Both individuals were arrested, transported to police headquarters, processed, and charged on summonses. Watson was additionally found to have active warrants totaling over \$7,000 from Brooklawn, Bellmawr, and Camden City. Both were released with pending court dates.

2/21 – During a motor vehicle stop, officers arrested Mario Tomasetto, 55, of Westville, after discovering an active ATS warrant for \$1,340.02 out of Brooklawn. During a search incident to arrest, officers located an empty green cylinder-shaped container commonly used to store CDS. Tomasetto was transported to police headquarters, processed, and charged with Possession of Drug Paraphernalia. He was released on a summons with a pending court date.

2/21 – Officers were dispatched to the Wawa in Brooklawn for a reported shoplifting. The store manager said a white male hid several items and left without paying. Surveillance footage was provided, and a still image was posted to the Brooklawn Police Facebook page. A witness contacted police and identified the suspect as Richard L. Albertson Jr., 41, of Atco. The ID was confirmed and Shoplifting charges were filed.

2/22 – While conducting a property check behind the Brooklawn Shopping Center, officers encountered Caroline Sanders, 24, of Haddon Twp., and Louie Desik, 43, of National Park. Desik was found to have four active warrants out of Gloucester City totaling \$3,205. Desik was placed arrested, transported to police headquarters, processed, and released. Both Desik and Sanders were charged with Trespassing.

2/26 – Officers observed Brian Carroll, 60, of Lebanon, and Stephen Mass, 61, of Clementon, sitting in the gazebo at Memorial Park drinking beer. Both were charged with open container violations under the borough ordinance. Stephen Mass was also charged with Trespassing.
