WHEREAS, the Borough of Brooklawn desires to seek funds from the N.J. Department of Community Affairs for the Waterfront Park Improvements; and


WHEREAS, the Borough of Brooklawn is responsible for the design and long-term maintenance of the Waterfront Park; and

NOW, THEREFORE BE IT RESOLVED THAT:

1. the Governing Body of the Borough of Brooklawn, County of Camden, State of New Jersey, that the application is hereby supported for N.J. Department of Community Affairs, Local Recreation Improvement Grant, FY2025 for the Waterfront Park Improvements; and
2. recognizes and accepts that the Department may offer a lesser or greater amount and therefore, upon receipt of the grant agreement from the New Jersey Department of Community Affairs, does further authorize the execution of any such grant agreement; and also, upon receipt of the fully executed agreement from the Department, does further authorize the expenditure of funds pursuant to the terms of the agreement between the Borough of Brooklawn and the New Jersey Department of Community Affairs.

BE IT FURTHER RESOLVED THAT:

1. any funding received as a result of this application will only be used for eligible costs for a project comprised of the improvements as stated in the application; and
2. that if the application is approved and accepted by the N.J. Department of Community Affairs, the sponsor agrees to the design and to provide the required long-term maintenance of the proposed improvements; and
3. the Mayor and Clerk are hereby authorized to execute and attest this resolution, application and agreement.
