

ORDINANCE # 21-2025

**ORDINANCE OF THE BOROUGH OF BROOKLAWN,
COUNTY OF CAMDEN, STATE OF NEW JERSEY,
AMENDING CHAPTER 150 OF THE ZONING CODE, AND
SPECIFICALLY AMENDING ORDINANCE 15-21;
ORDINANCE 4-22; ORDINANCE 13-22; AND ORDINANCE
13-23 OF THE CODE OF THE BOROUGH OF BROOKLAWN
PERTAINING TO THE HOURS OF OPERATION OF
CANNABIS FACILITIES.**

BE IT ORDAINED, by the Mayor and Borough Council of the Borough of Brooklawn, that the hours of operation for Cannabis facilities recognized within Chapter 150 of the Borough of Brooklawn Zoning Code, and specifically the following Ordinances of the Borough of Brooklawn, are hereby amended and supplemented, as follows:

SECTION I:

1. Ordinance 15-2021: Article I, Subparagraph A.2.(a)(8) and A.2.(b)(8). The aforementioned Sections shall be amended to read, as follows: “Hours of Operation shall be restricted to 9 a.m. to 10 p.m., Monday through Saturday, and 10 a.m. to 10 p.m. on Sundays.
2. Ordinance 4-2022: Article I, Subparagraph A.2.(a)(8) and A.2.(b)(8). The aforementioned Sections shall be amended to read, as follows: “Hours of Operation shall be restricted to 9 a.m. to 10 p.m., Monday through Saturday, and 10 a.m. to 10 p.m. on Sundays.
3. Ordinance 13-2022: Article I, Subparagraph A.2.(a)(8); A.2.(b)(8); and A.2.(c)(8). The aforementioned Sections shall be amended to read, as follows: “Hours of Operation

shall be restricted to 9 a.m. to 10 p.m., Monday through Saturday, and 10 a.m. to 10 p.m. on Sundays.

4. Ordinance 13-2023: Article I, Subparagraph A.2.(a)(8); A.2.(b)(8); and A.2.(c)(8).

The aforementioned Sections shall be amended to read, as follows: “ Hours of Operation shall be restricted to 9 a.m. to 10 p.m., Monday through Saturday, and 10 a.m. to 10 p.m. on Sundays.

SECTION II:

Any article, paragraph, subsection, clause, or other provision of the Code of the Borough of Brooklawn inconsistent with the provisions of this Ordinance are hereby repealed to the extent of such inconsistency.

SECTION III.

If any section, paragraph, subsection, clause, or other provision of the Code of the Borough of Brooklawn inconsistent with the provisions of this Ordinance be and are hereby repealed to the extent of such inconsistency.

SECTION IV.


This Ordinance shall take effect upon passage and publication according to law.

The purpose of this Ordinance is to amend and supplement Chapter 150 of the Borough Zoning Code, as well as to amend and supplement the following Ordinances concerning the hours of operation of Cannabis facilities: Ordinance 15-2021; Ordinance 4-2022; Ordinance 13-2022; and Ordinance 13-2023 to provide that the hours of operation for Cannabis facilities shall be Monday through Saturday from 9 a.m. to 10 p.m. and Sundays from 10 a.m. to 10 p.m. A copy of this Ordinance is available at no charge to the general public between the hours of 8:30 AM to 4:30 PM, Monday through Thursday (Legal Holidays excluded), at the Office of the Borough Clerk, Brooklawn Borough Hall, 301 Christiana Street, Brooklawn, New Jersey.
